Company will be entitled to receive royalties or licensing fees (herein collectively referred to as the "Royalties") as a result of such contract.

It is agreed that it is the clients responsibility to ensure that there are no spelling or grammatical errors contained in the final product. In the performance of his/her obligations of this Agreement, Artist shall be deemed an independent contractor. Click on any document name for more information. But between those two poles there are many other possibilities if only you would take the time to talk about them address them propose them. These clauses attempt to protect you from mistakes and minimize your liability. 16

The total number of performances during the term of this Agreement shall not exceed 4. Sales tax will not be applied to non-Virginia residents. This way if the project takes longer or the client has a bottleneck your cash flow isn't compromised. Nothing you put in a contract will protect you.
